WHEREAS, N.Y.S. Real Property Tax Law (RPTL) §458.6 established a Cold War Veteran's Exemption effective January 3, 2008, which exemption was adopted by the Town of Marshall by local law; and

WHEREAS, RPTL §458-b as originally enacted in 2007 provided that a Cold War Veteran's Exemption would expire after 10 years; and

WHEREAS, pursuant to amendments to RPTL §458-b enacted by the State Legislature in Chapter 290 of the Laws of 2017 a town can adopt a local law stating that the exemption will apply to qualifying owners without regard to the 10-year limitation;

NOW THEREFORE, be it enacted pursuant to RPTL §458-b that the Cold War Veteran's Exemption in the Town of Marshall shall apply to qualifying owners without regard to the 10-year limitation set forth in RPTL §458-b (2)(c)(iv).

This local law shall take effect immediately upon filing with the Secretary of State.
